to elect office bearers shall not be conducted unless majority of newly elected members of the board are present

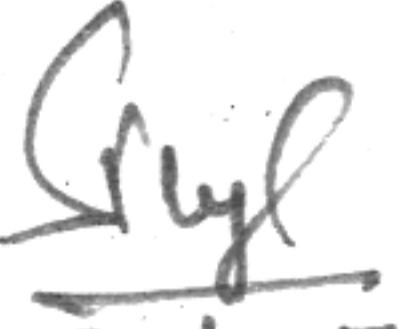
5. Further such meeting shall be presided over by Returning Officer.

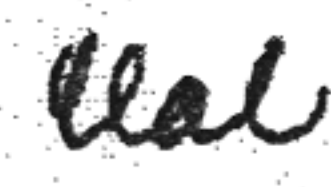


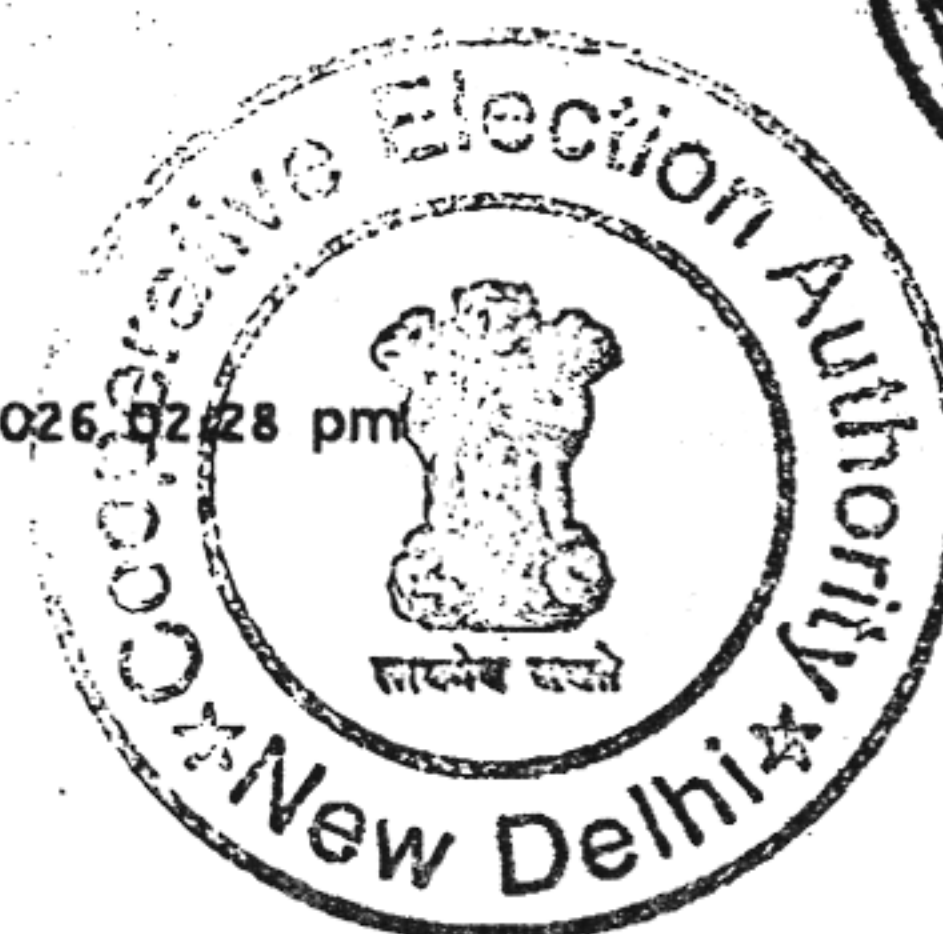

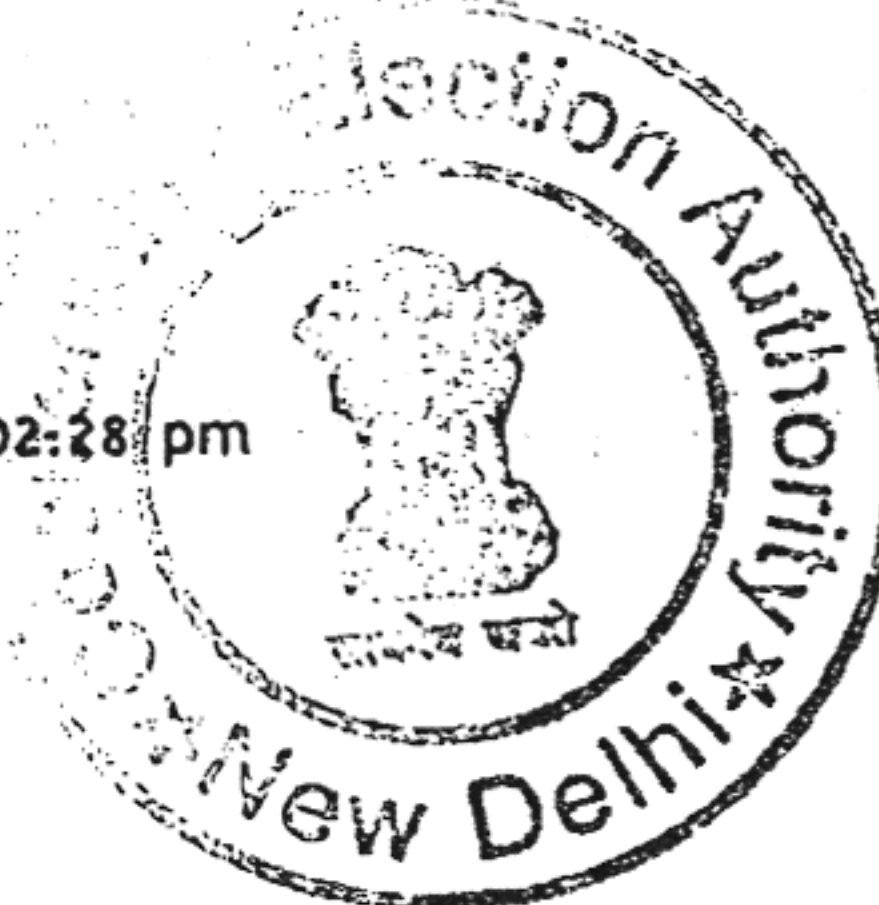
