

India lodges protest with US as 3 sailors go missing after attack

MEAs Summons US Official, Delivers Formal Demarche

New Delhi: Govt condemned a US attack on a commercial vessel off the coast of Oman on Wednesday that left three Indian crew members missing, while also officially lodging a protest with the US embassy here.

In a post on X, US Central Command claims crew of Palau-flagged Settebello 'repeatedly failed to comply with directions from American forces'

The protesting what was the second attack in the past few days by US forces on a shipping vessel with many Indian crew members on board.

Unlike the ship that was targeted earlier, Settebello is not blacklisted by the US Office of Foreign Assets Control, a point that Naidu made in the extended meeting that started at 8.45 pm and lasted for almost 25 minutes.

India had not condemned the first attack.

The Indian official sought an end to the targeting of commercial shipping, underscoring India's point that lives of seafarers are important.

hammad Fathali to protest an attack on Indian tankers transiting the Strait of Hormuz. MEAs said after the latest US strike on Wednesday that continuing incidents of attacks on shipping in the region are deeply worrisome and a direct result of the ongoing conflict in the region.

"We reiterate our call for immediate de-escalation of tensions, and the conclusion of ongoing negotiations for a diplomatic solution so that peace and stability can return to the region," said the ministry. Govt again underlined that the targeting of commercial shipping and civilian infrastructure in the region must end.

Talks set off buzz; Cong, TMC deny merger plan

Rapprochement Faces Resistance On Both Sides

Kolkata: Congress and Trinamool Congress on Wednesday denied any discussion on a merger after a flurry of high-level meetings in New Delhi triggered speculation that former West Bengal CM Mamata Banerjee's embattled TMC could seek shelter under the party she left 28 years ago.

For Mamata, the optics were striking. She cut her political teeth in Congress as a youth functionary before breaking ranks in 1998 to launch TMC.

Denials followed a 90-minute meeting between TMC national general secretary Abhishek Banerjee and Lok Sabha opposition leader Rahul Gandhi at 10 Janpath in New Delhi. A day earlier, Mamata and Congress parliamentary party chairperson Sonia Gandhi met for nearly an hour.

A senior TMC functionary dismissed reports of a merger as "baseless", saying, "As two parties, the discussions were not about a merger but how we work together." Asked about a possible TMC-Congress understanding for the upcoming bypolls in Nandigram and Rejinagar assembly seats and Basirhat Lok Sabha seat, he replied, "Too early to say."

Posting a photograph of the Rahul Abhishek meeting on X, TMC said the talks reflected a "shared commitment to safeguarding democracy, upholding constitutional values and working for welfare of every Indian. INDIA stands united."

Exodus on: Sushmita quits RS & party, meets Himanta

New Delhi/Kolkata: Rajya Sabha MP Sushmita Dev resigned from Parliament and quit Trinamool Congress on Wednesday, becoming the second dissenting Upper House member after Sukhendu Sekhar Roy to desert Bengal CM Mamata Banerjee as she battles an unprecedented post-election tumult within.

Dev had a meeting with Assam CM Himanta Biswa Sarma in Delhi the very day she resigned, signalling

where her political future might lie. Asked about reports of her joining BJP, she told reporters, "When I take a decision, I will let you know."

The former Congress member said she resigned due to "personal and political reasons". She said, "I don't want to be in a situation where I am in two boats at the same time. That is not the right way to do it... because, with the family background and upbringing I have, I have never stayed in one party and served another party."

Jairam Ramesh pushed back against speculation, saying reports on what transpired at Sonia's meeting with Mamata were "completely inaccurate". He wrote on X, "The meeting was very cordial and many personal matters were

talked about, given the long relationship they have had." Any rapprochement faces resistance on both sides, Congress veterans Adhir Ranjan Chowdhury and Abdul Mannan emerged as outspoken critics.

Fake gold pledged for loans in PNB, 15 booked in Jbp

Jabalpur: A major scam came to light in Madhya Pradesh's Jabalpur after gold kept as security against loans in a nationalised bank turned out to be fake. The loss to the bank on account of the fraud was estimated at Rs 43 lakh, police said, adding that a case was registered against 15 persons, including two empanelled gold valuers, after the fraud surfaced during revaluation of pledged ornaments at Punjab National Bank's Sadar branch.

According to the police, the fraud came to light after branch officials detected irregularities in several gold loan accounts



and ordered a fresh valuation of the pledged jewellery. During the reevaluation, gold ornaments submitted by 12 borrowers were found to be fake.

The city superintendent of police (CSP) Cantonment, Uday Singh Bagri, said the purity of the gold was initially certified by two panel valuers associated with the bank. The accused borrowers allegedly secured loans totalling Rs 38.81 lakh by pledging fake ornaments, police said, adding that the outstanding, combined with the interest accrued, is now Rs 43.17 lakh.

Goa court allows rape-accused doc to resume in hosp

Panaji: A fast-track court in Panaji has relaxed the bail condition imposed on a doctor accused of raping a woman in the ICU of a private hospital in Goa last year and permitted him to continue his MD there.

"After completing his degree and allied procedures, the accused shall not visit the hospital without court permission for any other reason till the matter is disposed of," said the presiding officer of the special court, Panaji, Pooja Kavlekar.

The doctor was arrested in May 2025 and released on bail in Oct, with one of the conditions being that he not visit the hospital or try to influence any witnesses.

He had approached the court, submitting that he had taken admission to the DNB course in general medicine at the hospital in 2023 but hadn't attended any sessions since Sept 2025. The doctor said he received a show-cause notice from National Board of Examinations in Medical Sciences in April, stating that if he remained absent for over a year, his admission would be terminated.

The court said although it was sensitive to the survivor's condition and believed that justice must prevail, it wouldn't be possible to "complete the case within one month" as the survivor hadn't even appeared before the police to record her statement. "This case, therefore, will take years to culminate," the court noted, and decided that under such circumstances, the doctor could not be kept out of the hospital.
